

The undersigned was appointed as Returning Officer by the MC of the Society vide its letter IECTC/2012/19<sup>th</sup> AGM dated 31.8.12 for holding the elections of the MC of Ircan Employees Cooperative Thrift and Credit Society Ltd.

Accordingly. the undersigned issued Agenda Notice dated 5.9.12 by Speed Post/Hand Delivered to all the members to hold the Election/Annual General Body Meeting on 10.10.12. Nomination forms were issued between 21.9.12 to 24.9.12. Nomination form filled by 10 candidates(one post each for President and VP and 8 post of MC Members, including 2 posts reserved for women) were scrutinized and all were found valid and accordingly a list of valid nominations was displayed on the Notice Board on 26.9.12. The date of withdrawal of nomination was on 27.9.12 and no candidate had withdrawn his/her nomination. The quorum of the meeting was observed up to 1400 hours and the adjourned meeting started at 1405 hours.
